By signing this form, I agree and I understand my commitment to the Fall CIMI GATE Trip 2018-2019 scheduled for Friday, October 19, 2018 through Sunday, October 21, 2018. This form must be completed, signed and returned with a **non-refundable deposit** of \$80 to reserve a spot by Friday, June 1, 2018.

(Please note: We are scheduled for 80 students. Priority is given to our current 7th grade students and final selection processed through a random lottery system. Any subsequent trip requests will be placed on a wait list.)

The total cost for the trip is \$280.00. This fee will cover the following:

- Boat travel to and from Catalina.
- Each full day with CIMI will consist of two three-hour program sessions and an evening program of approximately one to two hours in length. All programs are conducted by CIMI instructional staff.
- During program time our group, depending on availability, is entitled to the use of all relevant equipment and materials.
- Our group will be provided three nutritionally balanced meals each full program day. Meals provided by CIMI on partial days will be discussed with the group leader by CIMI staff prior to the visit and indicated in the contract.

I agree to stay current with the minimum amount due for the trip. The following denotes the minimum amount due in each student's trip account and form turn-in dates:

- Payment #1 of \$80 is due Friday, June 1, 2018 – \$80 total in trip account (along with Commitment Form)
- Payment #2 of \$100 is due by Friday, June 15, 2018 - \$180 total in trip account.
- Payment #3 of \$100 is due Friday, September 28, 2018 - \$280 total in trip account.

PLEASE NOTE! If a student is unable to travel on this trip for any reason after money has been paid, money can be refunded only on a very limited basis. Amounts due and timing of payments are calculated so that payments due to service providers can be met in a timely manner. Once money received from a student is used to pay an invoice, the money cannot under any circumstances be recovered from a service provider and refunded to the student.

Please note: No student will be allowed to travel on this trip if: the student has grades below "C"; has less than "S"atisfactory citizenship or has consistently exhibited inappropriate behavior during the school year.
